

## Customs power of attorney for Export Declarations – as a Direct Representative –

### Power of attorney:

The client authorizes LGI Logistics Group International GmbH (LGI) based on the Customs Department's General Terms and Conditions (Customs General T&C 2023) to handle customs for export consignments on its behalf and for its account and to undertake all actions associated with customs clearance. The Customs General T&Cs are available at [Guidelines & documents | lgi \(lgigroup.com\)](#). Upon signing the document, the customer recognizes the validity of the current Customs General T&C. It is explicitly referred to the liability restrictions of the General German Freight Forwarders' Standard Terms and Conditions 2017 (ADSp 2017). The Customs General T&Cs refer to the ADSp 2017. The power of attorney is valid with signature from the date of issue until 31 December of the following year.

### Information on export consignments:

All information and details required for issuing an export declaration are provided to LGI in writing directly from the client.

### Declaration process:

If the client does not have their own official customs authorizations for the simplified customs procedures, LGI will complete customs clearance using what is referred to as a standard procedure. LGI uses its own software for customs clearance.

- The client is aware that the export notice is only provided when handled properly by the customs office of exit. If an electronic ATLAS export procedure does not generate an export notice, LGI shall assume no liability for this.
- The client assumes the responsibility for the completeness and correctness of all documents and information required to execute orders. LGI is not obligated to check the documents for completeness and correctness.
- The client is responsible for export checks on the goods being exported.
